Dr. Deming on ISO 9000 and certification

"This shows how he is totally out of touch with the current world of Quality."

"Just have the system certificated and get it over with."



From performance to compliance

- Quality was performance improvement (TQM)
 - Ishikawa 7 tools
 - Juran project by project
 - Deming "Out of the Crisis"
 - Taguchi "Loss to Society"
- And then came ISO 9000 ...



Replacing goals by means

- The QMS and the certificate become the goal
- Quality 4.0: implementation of digital technology
- The pursuit of happiness ≠ the pursuit of money

• Humans as resource



The positive of certification

- Group effort focussing on quality
- Visible confirmation
- Motivational: celebrate
- A confirmation of a system
- But within the limitations of the certificate



The limitations of compliance

The one thing that in no way distinguishes you from your competitor is compliance. They are all compliant, otherwise they would not be your competitor.

The perception has been created that being compliant, corresponds to being excellent.



ISO added to that perception

- Contractual situation
- Fulfilling quality requirements
- Clear documentation demands






Excellence is a rare thing,

- When quality becomes compliance, complying will be seen as quality.
- If this is the most important topic for the quality community, we have lost all relevance at the strategic level

- Hire an editor and make it more readable.




A Sea of Standards, a Sea of Troubles?






A pareto approach


