

## **LIST OF ACCEPTABLE ALTERNATIVE STANDARDS TO ISO 22000:2005**

IRCA has determined that, for the purposes of compliance with the Food Safety auditor certification criteria, the standards referred to in this document, are considered to be acceptable alternatives to ISO 22000:2005

IRCA's evaluation of these standards consisted of a technical review for the purposes of validation of acceptability of an applicant's claim of experience "equivalent" to auditing to ISO 22000:2005. This evaluation is used only to determine whether audit experience using these standards meets the audit experience requirements stipulated in the IRCA auditor certification criteria. It is not intended as a technical review of the equivalence of a standard to ISO 22000:2005.

IRCA will update and reissue this list periodically.
