1. Context

This **Framework for the Management of Corporate Governance** provides the foundations and arrangements for managing Corporate Governance across the CQI.

1.1 What is Corporate Governance?

Corporate Governance is the set of relationships between the CQI's board, executive, members, and other stakeholders which provides the structure through which the objectives of the CQI are set, and the means of attaining those objectives and monitoring performance are determined.

1.2 Principles of this Framework

This framework is based on the seven principles defined in *the Charity Governance Code for Larger Charities*.

- Organisational purpose
- Leadership
- Integrity
- Decision-making, risk, and control
- Board effectiveness
- Equality, diversity, and inclusion
- Openness and accountability

1.3 Stakeholders for the CQI's Corporate Governance

The Board of Trustees – Require confidence that CQI governance is maintained and fit for purpose to deliver on stakeholder and strategic requirements.

Society – Requires the CQI to demonstrate good corporate governance.

The Charity Commission - Requires compliance with Charity law and the *Charity Governance Code*.

The Privy Council – requires compliance to the CQI's *Royal Charter & Byelaws*.

Members – Require confidence that CQI governance is transparent, maintained and fit for purpose.

Volunteers - Require confidence that CQI governance is transparent, maintained and fit for purpose.

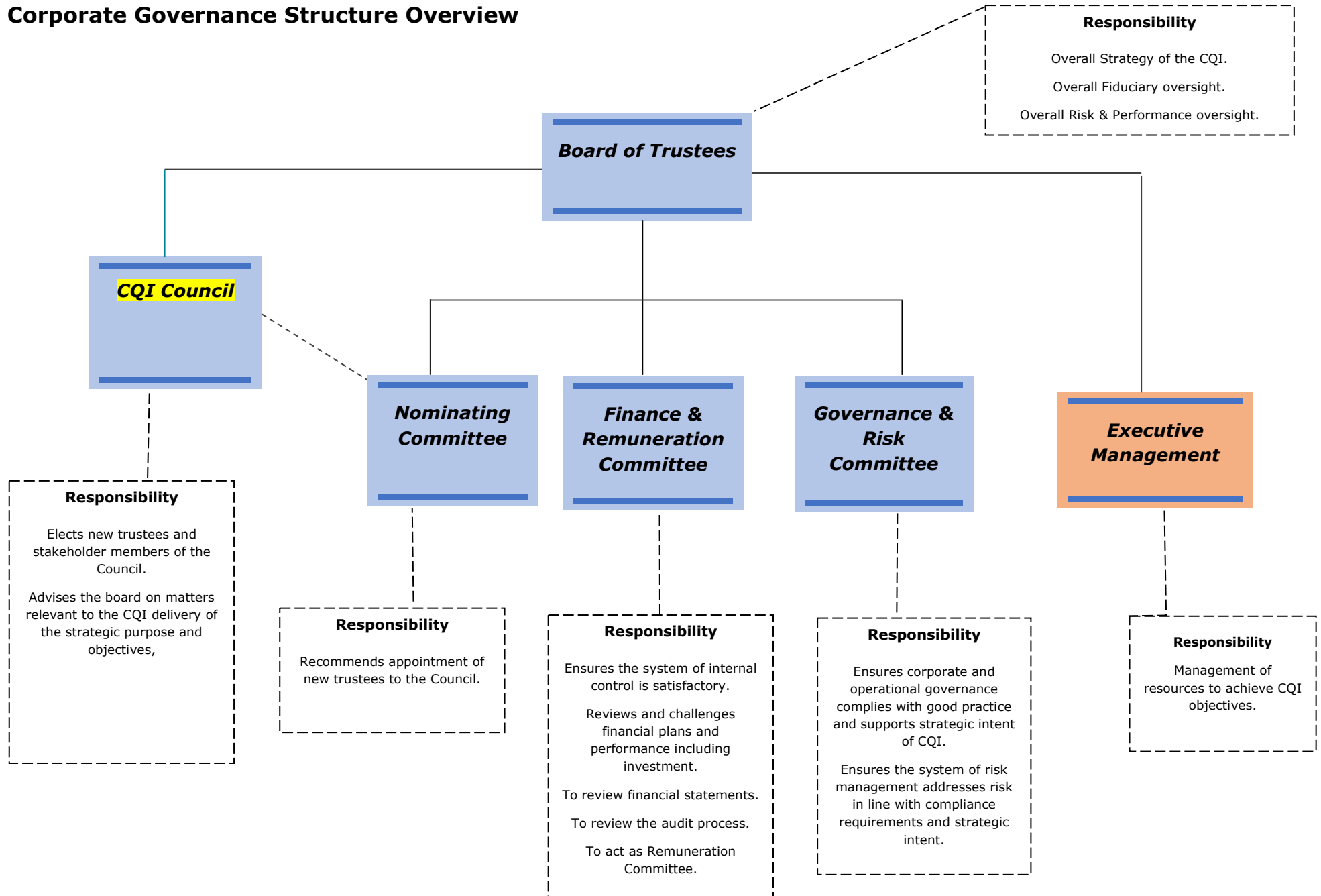
Employees - Require clarity over the interface between corporate and operational governance.
