
An introduction to the CQI and IRCA

Competency Framework

Governance: Ensures that all organisation requirements are reflected in operational frameworks, policies, processes and plans, and that these meet all stakeholder requirements



Assurance: Embeds a culture of assurance to ensure that policies, processes and plans are effectively implemented, and that all outputs (both internal and deliverable) are consistent with requirements



Improvement: Facilitates a culture of evaluation (both qualitative and quantitative), learning and improvement which drives more effective, efficient and agile ways of working to support business strategy, enhance reputation and increase profitability



Leadership: Uses leadership behaviours to maximise influence and develop a culture of evaluation and improvement



Context: Uses domain and/or industry-specific knowledge to ensure effective implementation of governance, assurance and improvement

Member grades

Quality and auditing are careers with many different starting points and many different career pathways. This is not a one-size-fits-all profession.

We offer different grades of membership to suit a variety of levels of experience and training.



CQI grades are designed to recognise your career progression, from interested Affiliate to experienced Chartered Quality Professional:



Affiliate

For any individual considering a career in the field, or with an active interest in quality. This includes senior managers who are supporting their quality team.



CQI Practitioners actively practice quality as part of their job role, including individuals who specialise in specific aspects of quality (such as inspection, quality assurance and auditing).



Chartered Quality Professional – Fellow

CQI Fellow is a prestigious grade which recognises individuals who have made an outstanding contribution to quality.



Chartered Quality Professional – Member

As a CQI Member, the main focus of your work is quality. Chartered Quality Professionals can adapt and apply their skills in most situations.



IRCA grades and schemes also reflect the industry-specific knowledge required by a successful auditor:

Internal



Provisional Internal Auditor

Suitable if you have attended an internal auditor training course, but have not conducted any audits. We offer you formal recognition of your training and abilities.

Internal Auditor

Suitable if you conduct internal 'partial system' audits of your own organisation's management system, or a supplier's management system.

You are probably not a full time auditor.

External



Provisional Auditor

Suitable if you have attended an auditor training course, but have not yet conducted any audits. You can gain formal recognition of your training and abilities.

Auditor

This grade is suitable if you conduct 'full system' audits as a member of a team or as a sole auditor. They may be internal full system audits, second-party or third-party audits.



Principal Auditor

Suitable if you are a senior audit professional with an extensive history of conducting full-system audits, but you may no longer lead teams or audit regularly. Principal auditors have often moved into training, consultancy or management roles.



Lead Auditor

This grade is suitable if you are competent in conducting 'full system' audits and are experienced in leading teams that carry out external audits.

William Lord Rolls-Royce Nuclear

"I joined The CQI because I wanted to be affiliated with an institute that would give me the representation and the credentials to be able to say: 'Yes, I am a quality professional'. Exploring the CQI special interest groups and events has allowed me to reach out to subject matter experts in other areas. Having that support mechanism is vital in your career.

"Since completing my CQI course in quality management, I've concentrated on the CQI's events and networking. I've found some of the guest speakers to be as useful as the actual training courses themselves in building up my knowledge and experience. I've been to a couple of the Nuclear SIG events and I also attend the local Nottingham Derby CQI branch.

Case Study

David Probyn *BAE Systems*

"The CQI is the only organisation I've joined in 30 years in the quality industry. The CQI's communications are in layman's terms, so we can actually show people a copy of the CQI magazine, Quality World. One of my colleagues mentioned that he was impressed with the CQI overview of ISO 9001:2015 – things like that are useful for academic knowledge, but also for the working environment as well.

"Recently, a CQI staff member talked to us about the value of being a trusted right-hand advisor who can give an independent view of what's going on in the business – rather than a functional lead. That struck a chord with me because that's how I've worked before. It's a great challenge in an organisation like this – a culture with 3,500 people – and it's a work in progress. Academics will tell you it could take 25 years or so but we're trying to do it in five or seven years.

"CQI membership certainly helps with credibility. The most valuable aspect of being a CQI member is the validation – there is a common logic between what we do and what the CQI stands for. From a personal point of view, it's good to know people who think in a similar fashion whom you can bounce ideas off. We can learn from them, and perhaps they can learn from us."
